- 3.1.2 Reduce pollution from all discharges (releases to air, water and land).
- 3.1.3 Reduce the use of toxic materials hazardous to the environment and humans.
- 3.1.4 Contain the highest possible percentage of post-consumer recycled content.
- 3.1.5 Usage of reusable packaging material to reduce waste.
- 3.1.6 Energy efficient power generation.
- 3.1.7 Conservation of water & power.

- 3.1.8 Usage of reusable and / or durable materials (recycling of waste water, lubricant oil recovery with skimmer, plastic, glass, tires, oil-soaked rags, batteries, and electronics are return to manufactures / suppliers for recycling purpose)
- 3.1.9 Minimization of transportation (local sources, concentrated local purchasing products).
- 3.1.10 Usage of multi-function materials, equipment & devices (e.g., copiers/printers/hardware, multipurpose cleaning products etc.) to reduce the number of products.

4. ROLES AND RESPONSIBILITIES

- 4.1. The C.E.O is authorized for policy approval.
- 4.2. The Admin, H.R. and policy committee ensures the communication and implementation of the policy.
- 4.3. The Admin, H.R. and policy committee drives the communication and implementation of the policy, provides specific advice on environmental issues, and ensures that environmental issues are identified and addressed in audits, reviews, measures and reports on environmental performance documented and implemented.
- 4.4. The environment policy committee encourage in participation for ensuring that policy and related standards are communicated, implemented and adhered that all relevant employees, contractors, growers, suppliers, customers, visitors and stakeholders are made aware of the policy and its requirements. We ensure local standard requirement compliance with the policy including adequate control measures to eliminate or reduce risks to express behaviors in breach with the policy.
- 4.5. The management, directors and HODs encourage, advises on policy content for review and update after every three years or as and when required, and ensures communication of policy efforts to external stakeholders e.g. Government bodies, customers, suppliers, contractors and visitors.
